

Gist of Proceedings of the 18th Annual General Meeting of the Company held on 30th September, 2023.

1. Date and Time of the Meeting.

The 18^{th} AGM of the Company was held on 30^{th} September, 2023 at 5.00 pm. The meeting commenced at 5.00 pm through physical mode and ended at 5.15 pm .

- 2. Proceedings in brief
 - Mr Manjunath Nayak, Director, chaired the proceedings of the Meeting.
 - The requisite quorum being present, the Chairman called the meeting to order.
 - Directors, Auditors and KMP's were present in the meeting.
 - The Chairman informed that the AGM was held through physical mode in line with the provisions of the Companies Act, 2013 and that requisite disclosures were submitted to the Stock Exchange from time to time.
 - The Chairman informed that the remote e-voting commenced on Wednesday, 27th September, 2023 at 9.00 am (IST) and concluded on Friday, 29th September, 2023 at 5.00 pm (IST).
